# 100 "Learn by Doing" Hands-On Courses

# 101 Rope Rescue Technician

This class will start at the beginning and will cover Basic, Intermediate and Advanced rope rescue techniques as required to meet NFPA 1006. Students should be physically capable of performing and demonstrating the skills required for meeting NFPA 1006 and capable of working in the low and high angle environment.

#### **PRE-REQUISITES/EQUIPMENT NEEDED**

Students will need leather form fitting/snug gloves, leather lace-up boots, and a rescue or fire helmet with chin strap. Personal gear may be used but must pass instructor inspection.

*Classroom session will be held off-site; hands-on training will be held on-site. This 5-day course will be offered Wednesday-Sunday. Class is limited to the first 25 students.*

## **102** Trench Rescue Technician

This five-day course is designed to offer a combination of classroom and practical evolutions that allow the student to learn proper techniques when dealing with trench collapse incidents. It will be a start-to-finish class to give the student knowledge and skills in trench **awareness**, **operations**, and **technician**, as addressed in NFPA 1670 and 1006. Students will work in straight, deep, "T", and "L" trenches using various shoring equipment. A heavy component of this class will be realistic hands-on operations, including below-grade work in a dirt trench.

#### PRE-REQUISITES/EQUIPMENT NEEDED

As per NFPA 1670 and 1006 a student should have Confined Space Rescue – Technician, Vehicle and Machinery Rescue – Technician, Hazardous Materials – Awareness, and High-Angle Rope Rescue – Operations. Students will need to bring a helmet, eye protection, gloves, steel-toed boots and outerwear (extrication coveralls, turnout gear **or** long-sleeved pants & long-sleeve shirt). Students are encouraged to bring their own hammer, but it is not necessary.

This course will be held off-site. This 5-day course will be offered Wednesday-Sunday. Class is limited to the first 20 students.

# 103 Confined Space Rescue Technician

This course teaches students how to conduct a variety of rescues in permit-required confined spaces. Students will learn how to develop and update pre-plans, conduct practice rescues, inspect and maintain equipment, and coordinate with other emergency responders. This training will consist of classroom and hands-on field training.

#### **PRE-REQUISITES/EQUIPMENT NEEDED**

Completion of a Rope Rescue course that meets minimums set forth in NFPA 1006-Chapter 6. Participants must bring a rescue helmet, gloves, and SCBA to this class.

This 4-day course will be offered Thursday-Sunday.

### **104** "The First Line" Engine Company Operations

"The First Line" Engine Company Operations will allow the firefighter to learn "Hands-On" fire hose operation techniques and advancing skills during live fire scenarios using the Fireblast Trailers, car fire burn props, and other propane burn props. This course will offer a great training opportunity for the new firefighter that has not yet had a chance to work a fire at these types of incidents, or for the firefighter seeking to polish their skills and learn new techniques for hose/nozzles during live fire scenarios.

#### **PRE-REQUISITES/EQUIPMENT NEEDED**

Prior completion of subjects listed on the Live Fire Course Competency Validation form. This form must be mailed in with payment. Full PPE & SCBA with a spare cylinder is required. All PPE must be less than 10 years old and SCBA cylinders within hydrostatic test date. Any student with facial hair that impedes the seal of the face piece will not be allowed to participate.

*Classroom session for this class will be held on-site; hands-on training will be held off-site. This 4-day course will be offered Thursday-Sunday.*

# 105 Rapid Intervention Teams

This advanced four-day class is designed for the experienced firefighter who wants to expand their knowledge, skills, and performance during RIT operations. The RIT classroom portion consists of various topics focusing on theory, preventative RIT operations, thermal imaging, and basic equipment utilized in RIT operations. This hands-on training course is <u>EXTREMELY</u> demanding, both mentally and physically. Hands-On Training evolutions reinforce and develop the skills of firefighter survival and rescue, mayday procedures, and RIT operations. Training will conclude with increasingly difficult scenarios utilizing basic skills and tools.

#### **PRE-REQUISITES/EQUIPMENT NEEDED**

Prior completion of subjects listed on the Live Fire Course Competency Validation form. Full PPE & SCBA with a spare cylinder is required. All PPE must be less than 10 years old and SCBA cylinders within hydrostatic date. Any student with facial hair that impedes the seal of the face piece will not be allowed to participate.

This course will be held off-site. This 4-day course will be offered Thursday-Sunday.

# 106 Hazardous Materials Operations (with Accredited Certification Testing)

These courses are to provide first responders with the information they need to take appropriate initial action when hazardous material incidents are encountered. Hazardous Material Awareness provides information to first responders to recognize the presence of hazardous materials, protect themselves, call for help, and deny entry to an area. Hazardous Materials Operations provides information for first responders to recognize the presence of hazardous mode to control the release and spread of the product, thereby protecting nearby persons, the environment and property. Practical exercises will be a component of this class.

#### **CERTIFICATION PROCESS**

Candidates may attempt written and skills testing for IFSAC Hazardous Materials Awareness certification on the first day of class. An attempt at IFSAC Hazardous Materials Operations written and skills testing is available the final day of class. Candidates attempting written IFSAC Hazardous Materials Awareness and Operations certification will submit a completed application to the Kentucky Fire Commission. The candidate shall remit the prescribed written test sitting fee of \$25, payable by fire department check or money order, and will attempt a written examination of multiple choice, true/false or matching questions. Upon successful completion of the written and skills exams, provided all documentation and fees are submitted, and prerequisites are satisfied, the candidate shall become eligible to receive an accredited certification from the Kentucky Fire Commission.

#### **PRE-REQUISITES/EQUIPMENT NEEDED**

Full PPE is required including SCBA and a spare cylinder.

This 4-day course will be offered Thursday-Sunday (with optional Accredited Certification testing as indicated above).

# 107 Principles of Firefighting

This course will cover each required topic set forth by the 2018 Edition of NFPA 1403 Live Fire Training. NFPA 1403 requires students to have knowledge of these topics to participate in Live Fire exercises. If you are wanting to participate in Live Fire exercises, then this is the course for you. The course will include classroom lectures and hands-on skill settings, ranging from basic firefighter training to Live Fire scenarios. This course is not just for the "Newest Guy" on the department, but an excellent refresher for seasoned members as well. Subjects listed on the Live Fire Course Competency Validation form will be covered in this class.

#### **PRE-REQUISITES/EQUIPMENT NEEDED**

Full PPE & SCBA with a spare cylinder is required. All PPE must be less than 10 years old and SCBA cylinders within hydrostatic date.

Lunch will be available to purchase at the site of the training for \$6 per person. This course will be held off-site. This 3-day course will be offered Thursday-Saturday.

# **108 Vehicle Rescue**

This class is designed for the first responder that wants to take their rescue skills to the next level! This hybrid class of auto extrication and heavy vehicle rescue will provide the student with the knowledge and skills to mitigate vehicle stabilization and extrication encounters from simple to complex. This intensive 3-day course will challenge you to work individually and in teams to respond to increasingly complex rescue scenarios. The auto extrication portion of the class will cover stabilization including basic wood cribbing, struts and other methods; the heavy rescue portion of the class will cover car/truck under ride, commercial trucks, busses, and heavy lifting. This hands-on training course is physically demanding.

#### **PRE-REQUISITES/EQUIPMENT NEEDED**

3-years' experience with rescue techniques and tools. Helmet, gloves, jumpsuit or turnout gear, fire/rescue footwear and safety glasses. No SCBA is required.

# **109 Junior Firefighter**

Learn from the Past and Prepare for the Future! Join fellow junior firefighters from around the state for a weekend of networking and education. Build your skills with plenty of hands-on training, including Junior Firefighter Program Guideline-approved live fire opportunity! This course is designed to teach the students team building, communication and leadership while honing the skills necessary to operate in today's fire service. Participants will be physically challenged at times and should be prepared to perform hands-on skills in full PPE. This class is open to junior firefighters ages **15-17** who are part of a departmental junior program recognized by the Kentucky Fire Commission.

#### PRE-REQUISITES/EQUIPMENT NEEDED

Full PPE including SCBA and a spare cylinder. Every Junior Firefighter must bring the required Training and Emergency Contact Form signed by the Fire Chief of their department.

This 3-day course will be offered Friday-Sunday.

# **110 Machinery Rescue**


Have you ever received a call for a subject stuck in an HVAC vent, a wedding ring stuck on a finger, or even a motorcycle accident victim impaled on a signpost? The rescuer often finds difficulty in approaching these situations simply because of the unknowns. This class will bring a new perspective to this type of incident. Instructors will provide "out of the box" ways of thinking that are usually not incorporated with normal fire service operations. This different train of thought will help the student develop a framework of techniques and tools that will make this operation smooth and safe. At the end of this class the student will be confident in proper tool choice for these incidents and able to operate with confidence on scene. This class focuses upon hands-on training using many different types of cutting tools to complete extrication scenarios.

#### **PRE-REQUISITES/EQUIPMENT NEEDED**

Safety glasses, helmet, turnout coat and work gloves.

This 3-day course will be offered Friday-Sunday.

# 111 Tactical Emergency Casualty Care

The 2<sup>nd</sup> edition of NAEMT's Tactical Emergency Casualty Care (TECC) course teaches EMS practitioners and other prehospital providers how to respond to and care for patients in a civilian tactical environment. The course presents the three phases of tactical care and integrates parallel EMS nomenclature including Hot Zone/Direct Threat Care that is rendered while under attack or in adverse conditions, Warm Zone/Indirect Threat Care that is rendered while the threat has been suppressed but may resurface at any point and Cold Zone/Evacuation Care that is rendered while the casualty is being evacuated from the incident site.

Patient simulations are incorporated into the course and will cover the following topics:

- Hemorrhage control including immediate action drills for tourniquet application throughout the course;
- Complete coverage of the MARCH assessment;
- Surgical airway control and needle decompression;
- Strategies for treating wounded responders in threatening environments;
- Caring for pediatric patients;
- Techniques for dragging and carrying victims to safety; and
- A final, mass-casualty/active shooter event simulation.

This course will be held off-site. This 2-day course will be offered Saturday-Sunday.

# 201 Fire Officer I

This course is designed to prepare students to successfully complete certification as Fire Officer I. This course is based on the content in IFSTA Fire and Emergency Services Company Officer 6<sup>th</sup> Edition. The course meets or exceeds NFPA 1021 Fire Officer I Standard for Professional Qualifications, 2020 edition. The target audience includes current company officers, acting company officers, and firefighters preparing for promotion to company officer. By completing all lessons, the student should be prepared for the Fire Officer I certification process. Students will have skill evaluation sheets, quizzes, and tests throughout the class prior to certification testing.

#### **CERTIFICATION PROCESS**

An attempt at IFSAC certification is available the last day of class. Candidates will submit a completed application to the Kentucky Fire Commission. The candidate shall remit the prescribed written test sitting fee of \$25, payable by fire department check or money order. They will attempt a written examination of 100 multiple choice, true/false or matching questions and participate in skills examination. Upon successful completion of the written and skills exams, provided all documentation and fees are submitted, and prerequisites are satisfied, the candidate shall become eligible to receive an accredited certification from the Kentucky Fire Commission.

#### PRE-REQUISITES/EQUIPMENT NEEDED

All class participants will need to bring a laptop. All students will need to purchase IFSTA Fire and Emergency Services Company Officer 6<sup>th</sup> Edition textbook prior to the class starting. It is highly encouraged that the students also purchase the study guide that goes along with the textbook. The study guide will help prepare the student for the certification testing. A free electronic edition of the class textbook is available through the Fire Commission's IFSTA eLibrary Grant Program (participants must have an IFSTA Resource One account).

To certify at this level, you must already possess: IFSAC Accredited Firefighter I and II certification and IFSAC Accredited Fire Instructor I certification.

#### **REGISTRATION PROCESS**

Students must be registered for this class prior to May 13, 2024. Class is limited to the first 32 students.

This 8-day course will be a hybrid offering; 4-hour virtual sessions will be held May 20, May 22, May 28, and May 29; classroom sessions will be held on-site Thursday-Saturday, with IFSAC Accredited Certification testing on Sunday.

# 202 Fire Officer II

This course is designed for the Fire Officer who is ready to assume more of a leadership role by moving into the middle-management level of his/her department. This course expands on the knowledge-base attained in Fire Officer I and also adds additional material including Management, Government Structure, and Departmental Budget Planning and Management. This course is based on the content of NFPA 1021: Standard for Fire Officer Professional Qualifications. This class will be student centered learning with group assignments for class presentation and skill sheet assignments.

#### **CERTIFICATION PROCESS**

An attempt at IFSAC certification is available if desired on Sunday or you can schedule at your convenience at a SFRT office location. Candidates will submit a completed application to the Kentucky Fire Commission. The candidate shall remit the prescribed written test sitting fee of \$25, payable by fire department check or money order when taking the written exam. The skill portion of the evaluation will consist of a portfolio that will be explained in class and submitted at a later date.

#### **PRE-REQUISITES/EQUIPMENT NEEDED**

All class participants will need to bring a laptop. All students will need to purchase IFSTA Fire and Emergency Services Company Officer 6<sup>th</sup> Edition textbook prior to the class starting. It is highly encouraged that the students also purchase the study guide that goes along with the textbook. The study guide will help prepare the student for the certification testing. A free electronic edition of the class textbook is available through the Fire Commission's IFSTA eLibrary Grant Program (participants must have an IFSTA Resource One account).

This 4-day course will be offered Thursday-Sunday (with optional written exam given on Sunday).

# 203 Modern Fire Service Leadership

Today's fire service is an ever-changing profession. Recently, many studies have been done on firefighting tactics that are producing hard to swallow changes and catchy phrases like "hitting it hard from the yard" and "beware of the flow path". One must ask themselves, "are we re-inventing the wheel, or do we really need to better understand our trade?" This course will discuss today's fireground and how we need to understand our enemy in order to achieve success. Modern building hazards and fire dynamics will be discussed as well tactical considerations such as search, VEIS, and ventilation. The importance of proper wearing of PPE and a discussion on the increase of maydays in the fire service will also be reviewed. This is a must attend program that will be valuable to all ranks from probie to chief of department.

# 204 Wildland Urban Interface for Structural Chief Officers (NFA Course)

This two-day course identifies operational activities and safety concerns for structural company officers assigned to a Wildland/Wildland Urban Interface incident. Topics covered include Introduction to Wildland/Wildland Urban Interface firefighting, interface environment, wildland fire behavior, command and control issues of wildland/urban interface firefighting, and tactics.

#### **PRE-REQUISITES/EQUIPMENT NEEDED**

All class participants will need to obtain a FEMA Student Identification (SID) number and provide it on the first day of class.

## 205 Emergency Scene Size-Up

The outcome of an emergency scene is often dictated by the initial size-up by the first arriving company officer or commanding officer. In today's fire service, often those making the initial scene size-up have limited to no critical decision-making training or experience. This lack of training may result in multiple issues, causing a fire scene to be reactive in nature instead of proactive. This course will provide insights on the decision-making process that should be conducted when observing multiple types of emergency scenes. Students will share experiences, opinions, and strategic thought processes to enhance our abilities enabling us to promote a more cohesive and efficient emergency scene operation. This course is designed for personnel who may be placed into the position of Company Officer up to Fireground Commanders.

This 1-day course will be offered Sunday.

# **300** Fire Investigations

# **301** Arson I – Fire Investigations for First Responders

This is the National Fire Academy course, "Fire Investigations for Fire Responders" (2022). The purpose of this course is to provide first responders with the tools to understand the key role they play in fire scene examination and in preserving and protecting important evidence for any subsequent investigation. The content of the course will provide a clear definition of the role of the first responder and identify the preservation and protection of evidence and proper reporting of the information to appropriate officials. This course exceeds the requirements of FIR 1035 in the KCTCS Fire Science Technology program.

#### **PRE-REQUISITES/EQUIPMENT NEEDED**

All class participants will need to obtain a FEMA Student Identification (SID) number and provide it on the first day of class.

This 2-day course will be offered Saturday-Sunday.

# **302** Arson II – Fire Scene Investigations

This is a comprehensive course with emphasis on techniques to determine the origin and cause of fires. Actual case scenarios will be incorporated to enhance this class. A wide variety of expertise is brought together through the cooperation of local, state, federal, fire, police and private investigators to provide the student with excellent instruction and detail. Report writing will be incorporated into this class.

#### **PRE-REQUISITES/EQUIPMENT NEEDED**

Prior completion of an acceptable Arson I course. You must have a signed permission form or letter from your chief prior to attending fire investigation courses taught by the Kentucky Chapter of IAAI. Students will need safety shoes, helmet, gloves, eye protection, laptop and digital camera.

This 3-day course will be offered Thursday-Saturday.

# 303 Arson III – Legal Issues for Fire Investigators

This course is the final and concluding level in arson investigations. The purpose of the course is to aid the Investigator in the preparation and presentation of their case in a court of law. This course emphasizes legal aspects, case preparations, trial procedures, and criminal enforcement. A mock trial is planned for Saturday morning, incorporating the Arson II class.

# 400 Fire Inspector & Fire Alarm/Sprinkler Industry

## 401 Continuing Education for Fire Suppression System Inspectors

This class will satisfy the requirements for the six (6) hours of continuing education for fire suppression sprinkler inspectors licensed by Department of Housing, Buildings and Construction in the state of Kentucky. The class will cover NFPA 25 for the inspection of water-based suppression systems.

This 1-day course will be offered Thursday.

# 402 Continuing Education for Fire Alarm Inspectors

This class is developed and presented for the industry professionals that are required to attend and receive recertification credit for licensure. It will help students have a deeper understanding of fire alarm systems. Class will have discussions as to where alarms are required, installed and maintained. Also, proper inspection of the systems, how they function, how they help save lives, and how they may benefit the fire service. This class qualifies for the six (6) hours continuing education required for State Certified Fire Alarm Inspectors.

# 403 Fire Inspector I

This class is the first step in the Kentucky State Fire Marshal's Inspector I Certification program. This class is designed for fire professionals that will perform fire prevention inspections on a daily basis. This class will provide instruction on NFPA 1 (2018 edition). This class will consist of instruction followed by an exam.

#### **PRE-REQUISITES/EQUIPMENT NEEDED**

Students need to bring pen and paper.

# 404 Fire Inspector II

This class is the second step in the Kentucky State Fire Marshal's Inspector II Certification program. This class is designed for fire inspectors and building code officials that deal with life safety issues on a daily basis. The student will get instruction on NFPA 101 (2018 edition). This class will consist of instruction followed by an exam.

#### **PRE-REQUISITES/EQUIPMENT NEEDED**

Students in this class must possess a Fire Inspector I certification for a minimum of six (6) months preceding Inspector II class start date. Students need to bring pen and paper.

# Carry/Conceal Weapons Policy Central Bank Center

The Central Bank Center is located in a School Zone as defined by the Gun Free School Zone Act 18 U.S.C. adopted November 29, 1990 (the Act). All persons are prohibited from possessing firearms on the premises unless such possession is authorized by exceptions in the Act. An exception to the prohibition is the carrying of weapons by law enforcement officials.

# 501 Emergency Operations Center/Incident Command System Interface (G191)

This course reviews Incident Command System (ICS) and Emergency Operations Center (EOC) responsibilities and functions and depends heavily on exercises and group discussions to formulate the interface. The course provides an opportunity for participants to begin developing an interface between an Incident Management Team and EOC personnel.

This 1-day course will be offered Thursday.

# 502 Community Risk Reduction & Recruitment and Retention

The first part of this course will review the basic concepts of Community Risk Reduction (CRR) and available Public Education Programs for departments in Kentucky, along with resources which can be utilized as agencies create and maintain CRR risk-reduction programs. Topics to be covered will include the Kentucky Firefighters Association (KFA) Community Risk Reduction "Sound Off" Safety Program, a review and use of available NFPA resources and various other programs available at no or reduced cost to agencies. The course will also cover basic concepts including tailoring your presentation to the appropriate age group and various learning concepts that both children and adults utilize in learning about the presented topic.

The second part of this course, Recruitment and Retention, is one of the largest challenges facing the fire service. The course will review opportunities which are being utilized across the state. These topics will range from your basic local recruitment drives to programs which are based within the school systems. There will also be a portion of the class dedicated to the review of the National Volunteer Fire Council's Recruitment programs, the overview of the KFA Citizens Fire Academy program guide and also group discussion on potential recruitment and retention opportunities in the future. Participants will have the opportunity to review and discuss the Kentucky Fire Commission's Junior Firefighter Program and the benefits of implementing such a program in their agencies.

# 503 Incident Management Team Type 4/5

Using classroom lecture and simulated incidents, the student will understand the role and function of an incident management team, the applicability of management principles to the incident management job and the special considerations of incident management within geographic areas of the Commonwealth. Course objectives are to train command staff positions to function as qualified local incident management teams who are able to assist in the management of large or highly complex all hazard incidents. The focus of the course is to better prepare team members within the local jurisdiction to address the unique and challenging management needs associated with these kinds of incidents within the jurisdiction.

This class offers a solid review of the ICS/IMT tools to get students started writing Incident Action Plans and commanding and controlling incident scenes and will incorporate "hands-on training" with intense practice of command and control while writing Incident Action Plans for Type 4/5 scenarios where each person will rotate from on-scene roles.

#### PRE-REQUISITES/EQUIPMENT NEEDED

This course is open to rescue, fire, emergency medical, emergency management, public health and law enforcement personnel or any organization wishing to be part of the local incident management team. Students must have completed IS-100, IS-200, IS-700, IS-800 and ICS-300. Priority will be given to those individuals that serve as a supervisor within an organization responsible for mitigating Type 4/5 incidents. Students will need to bring a pen and paper and it is recommended students bring a personal laptop (if possible).

This 3-day course will be offered Friday-Sunday.

## 504 Basic Chaplaincy

The Basic Fire Chaplain Training course includes course material designed to introduce the fire chaplain to ministry in the fire service. Topics include: Ministry to Firefighters, Ministry to Fire Victims, Critical Incident Stress, Fire Department Funerals, Fire Chaplain Operations, and many others. This class is partial fulfilment for state fire chaplain certification.

This 2-day course will be offered Friday-Saturday.

#### Lead Instructor: Rebecca Brown, Kentucky Federation of Fire Chaplains

# 505 After The Fire: What Happens When The Fire Trucks Leave?

This course will review the basic concepts of what occurs after the fire department leaves the scene. Participants will gain knowledge that will allow them to further document the fire incident in NFIRS regarding looking at true fire loss (property and content values) and guide participants in the process the resident or business owner will face in their return to normal. This course also expands on the concept of Community Risk Reduction by furthering participants' knowledge of assisting their residents in a return to "normal". Additional topics will touch on the importance of on-scene items such as salvage and overhaul and the need for furthering these events to assist with reducing loss. A review of the post-fire insurance process will also be included to allow participants to see which items are considered property versus contents and the various policy coverages insurance companies utilize.

This 1-day course will be offered Friday.

## 506 Managing the Mayday - Are You Prepared?

Rapid Intervention is a concept that is over complicated by many. The mission is quite clear - soften the structure and if put to work - locate, package and rapidly remove the downed firefighter. Time is of the essence and a cache of tools is not always available. This program will address the preparation required as well as skill sets needed to properly function as a RIC. Case studies and lessons learned will be used to reinforce the program's agenda.

# 507 Public Information/Public Affairs

The focus of this course is to cover some of the basics of being a Public Information Officer (PIO) and managing Public Affairs for your department. During the course, students will learn techniques for doing on camera interviews, writing a press release, interacting and managing the news media and telling your department's story. Students will also learn social media techniques and marketing your department on social media as well as the do's and don'ts of social media.

# 508 Emergency Response to EV Incidents

Emergency Response to Electric Vehicle Incidents is designed to introduce first responders to the basic design and hazards of battery operated or hybrid vehicles and provides students with the advanced knowledge and skills needed respond to and address electric vehicle emergencies. Students will leave prepared to operate as a member of a team capable of responding to emergencies involving alternative fuel vehicles where advanced vehicle rescue may be needed.

## 509 Grant Writing for Fire Departments

This course will provide an introduction to grants and the grant process. There will be discussion on various types of available grants, statistics and information for the current federal grant cycle. The class will cover how to apply the MHFA Action Plan (ALGEE) in scenarios designed specifically for Fire/EMS professionals, along with national, regional, and community mental health resources for Fire/EMS professionals. It focuses on the unique experience and needs of Firefighters/EMS personnel and is a valuable resource that can make a difference in their lives, their coworkers' and families' lives, and the communities they serve.

# 511 Bourbon Rick House Fires/Containment/Attack

This course will discuss historical fires involving the bourbon industry. There will be a detailed presentation on the building construction of rick houses and the distillation processes along with the properties of Ethanol, and how to and when to conduct an offensive or defensive fire attack on a rick house fire. There will also be discussion on how to mitigate an overturned transport vehicle that is carrying ethanol/flammable liquids and when a bourbon "slop" truck overturns. Tabletop exercises will be incorporated into the learning modules.

# **512 Emergency Response to Construction Site Incidents**

Driving through your district today you will see multiple construction sites varying in size. These sites pose risks to first responders because of the hazards within and aren't typically visited unless there is an issue. In most cases an organization is not prepared for what lies beyond the construction entrance. Whether Industrial, Commercial or Residential, they are all unique but share the same risks. This course is designed to exploit the major risks faced by the first responder as well as educate on the basic tasks being completed. Topics include Trenching/Excavation, Fall Protection, Confined Space and many more areas which are performed at jobsites in department districts daily. These tasks may require a special response, and these are issues that need to be addressed before an incident occurs. # 513 Lithium-Ion Battery Fires In A Residential Structure

Bikes, scooters and other devices have become popular modes of transportation. These devices often times use lithium-ion battery technology because of the decreased weight and high energy density associated with this technology. These types of fires burn hotter and faster and require special considerations and tactics. This course provides first responders with the knowledge to respond to these

types of incidents.

Part II of this course will highlight electric vehicle fires in parking structures. As electric vehicles (EVs) have become increasingly popular, it's essential for parking garage operators, emergency responders, and EV owners to understand the unique challenges and safety considerations related to EV fires. This comprehensive course provides participants with the knowledge and skills needed to effectively mitigate, respond to, and prevent electric vehicle fires in parking garages.

# 514 Occupational Cancer Prevention & Mitigation

The course also provides a practical hands-on portion which teaches students to perform Personal and Gross Decontamination. We will also discuss SOP and SOG generation and the current national best practices.

# Live Fire Course Competency Validation/Fitness for Duty Form Required for all students before participating in SFRT Live Fire Training

NFPA 1403 (2018 Edition) 4.3.1 - 4.3.3 require that all participants must have prior training and meet prerequisites in certain subjects before participating in live fire training. These minimum subjects include:

1) Safety; 2) Fire Behavior; 3) Portable Extinguishers; 4) Personal Protective Equipment & SCBA; 5) Ladders; 6) Fire Hose, Appliances, and Streams; 7) Overhaul; 8) Water Supply; 9) Ventilation; 10) Forcible Entry; 11) Building Construction. Specific prerequisite training must also be met in these areas: Fire Dynamics; Health and Safety; Fundamentals of Fire Behavior; Fire Development in Compartments; Nozzle Techniques and Door Control.

NFPA 1403 (2018 Edition) 4.4.1 requires that all participants must be rehabbed in accordance with NFPA 1584, Chapter 6. Before being released from the rehab area to participate in a State Fire Rescue Training live fire training evolution, normal conditions are considered to consist of: heart rate of 60-100; respiratory rate of 12-20; systolic blood pressure less than 160; diastolic blood pressure of less than 100; pulse oximetry of 95% or greater. Participants are encouraged to periodically check their vital signs and seek appropriate medical attention for abnormal signs/symptoms.

Participants must be at least 18 years of age and a member of a Fire Department or an Industrial Fire Brigade recognized by the Kentucky Fire Commission to participate in live fire training delivered by State Fire Rescue Training. ID's will be checked by SFRT instructors before allowing students to participate in live fire training. All turnout gear must be less than 10 years of age. Per NFPA 1403 (2018 Edition) A4.9.5 it is recommended that all participants wear full-length clothing made of natural fibers or fire-retardant materials under their personal protective equipment during live fire evolutions.

Facepiece seal protection: SFRT requires that all students must be compliant with OSHA 29 CFR 1910.134:

"<u>1910.134(g)(1)(i)</u>-The employer shall not permit respirators with tight-fitting facepieces to be worn by employees who have: <u>1910.134(g)(1)(i)(A)</u>- Facial hair that comes between the sealing surface of the facepiece and the face or that interferes with valve function;" (hair growth between the skin and the facepiece sealing surface, such as stubble beard growth, beard, mustache or sideburns which cross the respirator sealing surface).
